The National Enforcement Academy provides WAMITAB accredited training for enviro-crime enforcement professionals and aims to provide a common and consistent approach to enforcement across England. It allows for recognition of professional standards, by ensuring training is relevant and the knowledge and skills acquired on the course can be applied, immediately making an impact on the work of the officers.

Learning outcomes

By the end of the training, candidates will:

Day 1

- Understand the principles and challenges of working in an enforcement role

Day 2

- Understand the core principles of enforcement and procedures for issuing fixed penalty notices, as well as learning the law and enforcement tools for tackling local environmental quality issues

Day 3

- Implement and practice issuing fixed penalty notices, learn the law relating to waste crime and understand community impact assessments

Day 4

- Identify the essential requirements necessary for inviting suspected offenders to attend a voluntary interview (PACE) and practice interviewing suspects.
- Understand the practical elements of preparing a prosecution case for trial

Day 5

- Explore the court process in a simulated environment to establish confidence and awareness for authentic cases



Duration

What next?

On completion of the five day course, attendees will be required to complete an online test before being awarded a certificate. The accreditation will then last for 24 months at which stage candidates will be required to complete the refresher course, Enforcement Academy Continued Competence.

This accredited course is suitable for existing or aspiring enforcement officers/practitioners responsible for environmental crime and waste management enforcement.

Enforcement academy - continued competence

Enforcement Academy Continued Competence is an integral component to maintaining your WAMITAB Accreditation as an environmental enforcement officer. The Continued Competence course builds on the knowledge gained when you undertook the 5 day National Enforcement Academy and will include any changes to legislation within the last two years.

Learning outcomes

Candidates will receive an update on:

- Environmental legislation refresher and update
- Issuing Fixed Penalty Notices
- Simulated PACE interview
- Drafting witness statements
- Preparation of exhibits, case file and summons for prosecution
- Drafting a schedule of aggravating and mitigating circumstances of offending
- Consideration of environmental sentencing guidelines and application in practice

The session will include;

The provision of best practice techniques and incorporate real life case scenarios to make the learning experience realistic for enforcement officers.

Litter from vehicles Enforcement

Tackling litter louts who mindlessly throw rubbish from their vehicles can now be dealt with through new powers to impose Fixed Penalty Notices. This is a civil regime as the fine can be levied against the vehicle keeper. This one day course will clearly explain all the steps local authorities need to take to implement an effective strategy to carry out this important enforcement activity, as part of a broader approach in the plight to keeping our communities litter free.

When litter is thrown from a vehicle it can be difficult to identify the offender.

Legislation to tackle litter louts and those who mindlessly throw rubbish from their vehicles enables local authorities to issue a penalty charge notice to the keeper of a vehicle from which litter is thrown, even if the identity of the person who threw the litter cannot be established.

This course provides an in-depth understanding of the civil procedure, to include the appeal and adjudication process, which must be adopted by any local authority looking to include this enforcement tool in its armory to deal with litter and help improve environmental quality.

Learning outcomes

By the end of the training, candidates will:

- Fully understand the complexities of the civil procedure and layered appeals process for dealing with littering from vehicles.

Duration

The traditional class-room version takes one day or we can deliver the course virtually via MS Teams or Zoom over 2 sessions (3 - 4 hrs per day)

Cleaning up the neighbourhood - vehicle issues

This one day course will provide a complete overview of legislation pertaining to powers for tackling vehicles issues in an attempt to clean up the neighbourhood.

Learning outcomes

By the end of the training, candidates will:

Possess an understanding of the legislative frameworks relating to the following acts and regulations;

- Clean Neighborhoods and Environment Act 2005
- The Local Government (Miscellaneous Provisions) Act 1976
- The Highways Act 1980

Environmental legislation - cradle to grave and beyond

This one day course will provide a complete background and overview of environmental legislation in relation to waste crime, applicable to regulation and enforcement issues affecting street scene and local environmental quality.

Learning outcomes

By the end of the training, candidates will:

Gain an understanding of environmental crime in relation to applicable acts and regulations:

- The Waste (England & Wales) Regulations 2011
- Clean Neighbourhoods and Environment Act 2005
- Environmental Protection Act 1990
- The Environmental Protection (Duty of Care) Regulations 1991
- Control of Pollution (Amendment) Act 1989

- Understand how the legislative framework is applied in practice, including case law overview, drafting and issuing fixed penalty notices, strategy and partnership
- Display practical skills in and understand the legal process for prosecution. Including evidence gathering and case preparation, PACE interview techniques & practice and the court process
- Understand the powers of the court and sentencing guidelines

Dog fouling and control

This one day course aims to provide a full overview of the law in relation to dog fouling and the relevant control mechanisms that can be adopted to manage local environmental quality.

Issuing fixed penalty notices

This one day course aims to provide patrolling officers with a full understanding of the law in relation to Fixed Penalty Notices and the practical implications of issuing notices, along with the techniques required to prepare a prosecution case for trial.

- Create effective witness statements and know how to give evidence at trials
- Understand court powers and sentencing guidelines

It delivers an overview of requirements as set out in the Code of Practice on Litter and Refuse and links this to monitoring to ensure standards are being met. The course can be adapted to include bespoke elements relevant to your organisation.

Learning outcomes

By the end of the training, candidates will be able to:

- Identify the occurrence of litter, detritus, graffiti and fly-posting (or alternative elements if required)
- Identify various land use types
- Determine survey site dimensions over different land uses
- Differentiate between different standards of cleanliness in accordance with COPLAR
- Practice on-street grading for levels of litter, detritus, graffiti and fly-posting (or alternative elements if required)
- Record data
- Identify how information can be used to inform service delivery effectiveness
