### Keep Britain Tidy Annual Network Conference

Foreword by Allison Ogden-Newton OBE CEO, Keep Britain Tidy

#### Welcome to Liverpool for Keep Britain Tidy's annual Network Conference. It is hard to believe that it is only 12 months since we were last together in York.

Harold Wilson famously said that a week is a long time in politics. If a week is a long time, then a year is an eternity and one thing is certain, an awful lot has changed in the past 12 months.

We are now almost eight months into a new Labour government and we are delighted that we will be hearing from Parliamentary Under-Secretary of State (Minister for Nature) Mary Creagh CBE MP during the conference about the government's plans to tackle the massive environmental challenges we face as a country.

The people at this conference understand more than most the scale of those challenges. You are at the coalface, seeing on a daily basis the devastating impact of a wasteful, consumptiondriven society on our environment and our communities. Whether that is the ever-present and persistent problem of litter, the scourge of flytipping or the impacts of extreme weather events, caused by climate change, on the environment on our doorstep.

At this conference, we will be talking about our new report on the state of litter in this country. We chose the title - A Rubbish Reality - carefully.

A 'rubbish reality' is what we are facing. Sadly, and despite the heroic efforts of both councils and volunteers, we are in the midst of a tsunami of litter and waste.

Nowhere escapes the scourge of litter. From the middle of our cities to our remote beaches, it is everywhere. It is only as a result of our annual litter survey that we are able to quantify the scale of problem at a national level. We have continued to undertake our survey every year, despite a lack of funding from government, because we believe it is crucial to understand how much litter there is, where it is and what it is made up of.

Our new report answers all those questions, reflecting not only on our latest survey data but on the trends over time.

It makes for stark reading and tells us something that everyone, if they are honest, instinctively knows - litter is a big problem and it is one that is not going away.

More than 90% of the places our surveyors visited in the years between 2013 and 2024 were littered. How have we got to a point where only nine out of every 100 places are litter-free?

And it isn't just the litter that is contributing to environmental degradation of our communities. When you factor in fly-tipping, fly-posting and graffiti as well, only seven out of every hundred places we visited were not blighted by at least one problem, if not more.

Sadly, the impacts of litter are not the same for everyone, though our research shows us that everyone cares about it. Eighty-three per cent of people say litter is a problem in this country and a similar proportion (77%) think the problem is getting worse.

Our surveying reveals that most deprived communities are disproportionately affected by litter, with only two per cent of sites litter-free in the most deprived areas as opposed to 14% in the least deprived. It is also clear that people are aware of the scale of the problem in their area. Seven in ten people in the most deprived areas agree that litter is a problem where they live, falling to just over half (56%) in the least deprived places.

Why does all this matter and why do Keep Britain Tidy carry out research and write reports like this?

Litter, as our report shows, is a barrier to investment and impacts people's feelings of safety, health and wellbeing. If we are to create communities where people can thrive, we need to create an environment that is free from litter.

There is no doubt that the deposit return scheme for drinks containers that are metal cans or plastic bottles, which is thankfully now set to be introduced in 2027, will have a significant impact on this type of litter, but there is still so much more to be done.

Today you will hear about some of the work Keep Britain Tidy is leading as part of our mission to rid this country of litter, including our work to reduce smoking-related litter which, I am pleased to report, has reduced littering of cigarette butts by 17%.

Many of you will be aware of the work of the Chewing Gum Task Force. Indeed, many of you will have benefitted from the grants scheme. That work continues and we will be talking about the Task Force and its impact, as well as launching the latest round of funding.

The Great British Spring Clean is our flagship campaign and, for many, is now a fixture in the calendar. Hundreds of local authorities, community groups, businesses and other organisations will be supporting this year's clean-up, our tenth, and will celebrate all the incredible volunteers who share our desire to rid the environment on our doorstep of the scourge of litter.

As you will see, Keep Britain Tidy is doing everything it can but there is so much more that needs to be done and it cannot be left to cashstrapped local authorities and charities alone.

That is why, today, we are calling for the extended producer responsibility for packaging legislation to be extended to litter on the ground as well as the rubbish that finds its way into a bin. The work to change behaviour, to stop litter being considered to be a 'normal' part of life that we are all forced to accept, requires commitment from government, from businesses and from local authorities. It also requires a comprehensive and robust strategy, measurement to enable us to see if we are making progress and, finally, it needs funding.

We have had a litter strategy from government in the past but that strategy did not have targets and was not resourced and we can now see, from our report, that it has had no impact on the problem.

I hope you will find this year's conference interesting and informative. The team at Keep Britain Tidy look forward to chatting to you as we come together to look for ways to change our 'rubbish reality' and improve the environment on people's doorstep so everyone can love where they live.



#### **Chewing Gum Task Force**

The Chewing Gum Task Force brings together some of the country's major chewing gum producers, including Mars Wrigley and Perfetti Van Melle, as well as some producers of nicotine replacement therapy gum. Under the scheme, administered by Keep Britain Tidy, the firms will invest up to £10 million over five years to help reduce chewing gum litter.

This year, grants of up to £27,500 will be available to individual councils in England, Northern Ireland, Scotland and Wales to fund street cleansing and/or the purchase of cleaning equipment.

Councils will also benefit from a bespoke gum litter prevention package, including targeted behaviour change signage and advice, which has been shown to reduce gum littering by up to 80%.
